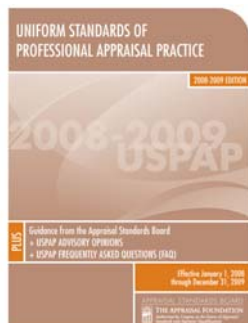


7-Hour National USPAP Update Course

This course fulfills the 7-hour national USPAP mandate as established by the Appraisal Qualifications Board (AQB) of the Appraisal Foundation.

Learn the key features of the 2008-2009 USPAP and re-familiarize yourself with its Rules and Standards.

The 7-hour course focuses on edits made to create the most recent version of USPAP. Changes include elimination of the Supplemental Standards Rule; edits to the Conduct section of the Ethics Rule; edits to the Comment of SR 2-3 (certification); elimination of Statement 10; elimination of three Advisory Opinions; and retirement of Advisory Opinion 5.

About the Instructor. Dennis Badger is the Chief Investigator for the Kentucky Real Estate Appraisers Board in Lexington, Kentucky. He is a Certified General Real Property Appraiser and has appraised a variety of residential, commercial, and industrial properties. He has served as the Chair of the Investigator Training Subcommittee for the Association of Appraiser Regulatory Officials since 2004 and serves on the State Regulator Advisory Group to The Appraisal Foundation.
